Transition to REEport

- CRIS: USDA's documentation and reporting system for publicly-supported projects
- REEport: a new reporting system which format is based on the RPPR
- Incremental transition from CRIS to REEport



Version 1 of REEport will be deployed in 4 stages

- Non-formula Grants
 - Stage A: project initiation; Oct 1, 2010
 - Stage B: progress/termination; Jan 14, '11
- Formula Grants
 - Stage C: project initiation; Oct 1, 2011
 - Stage D: expenditure/progress/termination; Oct 1, '11
